 - 1.1.1 Copyright and Neighboring Rights Act Chapter 68:02 of 2000
 - 1.1.2 **Pending Changes:**
 - 1.1.2.1 The amendment intend to include and domesticate the new treaties being Beijing and the Marrakesh Treaty. It also aims to improve and fully incorporate provisions of WIPO Copyright Treaty and WIPO Performance and Phonographs Treaty

2.1. Stipulations concerning collective management of rights in your copyright law and/or regulations

2.1.1 36A. Establishment of Copyright Society

- (1) There shall be established, for the various categories of works protected under this Act, a collective administration body to be known as the Copyright Society of Botswana.
- (2) The Copyright Society shall be a non-profit making company limited by guarantee, and shall be responsible for-
 - (a) the negotiation and granting of licences in written agreement with the owners of copyright for:
 - (i) the adaptation of works, performances and sound recordings,
 - (ii) the insertion of works, performances or sound recordings in other scopes,
 - (iii) the use of works for publicity purposes;
 - (*b*) setting rates for royalties in accordance with acceptable international standards; and
 - (c) the collection and distribution of royalties to appropriate owners of copyright.
- (3) The Copyright Society shall:
 - (a) represent the owners of the copyright in the various categories of works protected under this Act; and
 - (*b*) put in place rules and regulations, approved by the Copyright Office, which contain such provisions as are necessary to ensure the protection of the interests of its members.

2.1.2 Section 36B. Duties of Copyright Society

- (1) The Copyright Society shall, as soon as reasonably practicable after the end of each financial year, submit, to the Copyright Office-
 - (a) a report of its operations and performance during the year in question;
 - (b) a copy of its audited financial statements in respect of that year; and
 - (c) a copy of such other reports as may be requested by the Copyright Office.
- (2) The Copyright Society shall distribute royalties on an equitable basis, approved by the Copyright Office, to its members.

2.1.3 Section 37. Regulations

- (1) The Minister may make regulations providing for any matter which under this Act is to be prescribed or for the better carrying out of the purposes and provisions of this Act.
- (2) Without prejudice to the generality of the subsection (1), the Minister may make Regulations to-
 - (a) establish, constitute and provide the functions of a Copyright Council to administer the Act and to regulate the rights protected under the Act;
 - (*b*) provide for the setting up of a Copyright Society and such other body of persons necessary to promote the rights protected under the Act.

 - 2.3.1 The Copyright Office, a department under Companies and Intellecttual Property Authority (CIPA)
 - 2.3.2 CIPA a parastatal under the Ministry of Investment Trade & Industry
 - 2.3.3 The Copyright Office:
 - 2.3.3.1 responsible for all matters affecting copyright in Botswana;
 - 2.3.3.2 supervise the activities of the Copyright Society of Botswana as provided for under section 36A of the Act;
- 2.4. Competition legislation and its applicability to collective management
 2.4.1 the Copyright Society of Botswana as the only CMO in the country holds a monopolistic position

 - 3.1.1 the Copyright Society of Botswana
 - 3.2. Year of incorporation and year when licensing begun 3.2.1 COSBOTS was incorporated in 2008 and begun operations and licensing in 2011.

 - 3.3.1 COSBOTS is a multipurpose CMO. Having started licensing for music in 2011 and only introduced reprography in 2016. The CMO intends to introduce Audio visual and dramatic rights licensing in the second quarter of 2020.

 - 3.4.1 an employee complement of 19, 15 staff and 3 interns.

 - 3.5.1 authors, composers, publishers and producers of music works
